- **SUBJECT:** Notification of <u>Administrative Modification #4</u> to the FY 2025 FY 2028 Transportation Improvement Program (TIP) and Administrative Modification #7 to the 2050 Metropolitan Transportation Plan (MTP)

On February 21, 2025, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #4 to the FY 2025 – 2028 TIP and Modification #7 to the 2050 MTP.

Administrative Modification #4:

This modification adds supplementary funding for two existing projects. Both projects are classified Grouped Projects¹ (Highway Safety Improvements), which do not impact the financial constraint of the TIP.

Richmond Road Safety Improvements (MTP ID: FAY-123, KYTC ITEM #: 07-9012.50)

• This modification adds an existing project from the previous TIP and increases the SLX amount for the CN phase from \$1,500,000 to \$1,750,000 to cover cost increases. No local or state match is required in this case. The DN, RW & UT phases were funded in the previous TIP.

West Main & Buchanan Safety Improvements (MTP ID: FAY-205, KYTC ITEM #: 07-3203.00)

- This modification increases the SLX funding to cover cost increases for the RW and UT phases.
 - o Increase RW from \$110,000 to \$150,000 (\$120,000 SLX (80%) + \$30,000 Local Match (20%))
 - o Increase UT from \$40,000 to \$200,000 (\$160,000 SLX (80%) + \$40,000 Local Match (20%)).

¹ The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).
