

Other Information: This TIP Modification modifies specific funding levels listed in Tables 6 and 7 for Transit Capital Projects for GO bg Transit and Community Action of Southern Kentucky. Purchase of New Buses & Purchase of Transit Operating Equipment are project types identified in the Grouped Projects Table of the 2016 - 2020 MPO Transportation Improvement Program (TIP), therefore a formal TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP and MTP by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects Table involves a commitment of additional funding for the project by the project sponsor (FTA/GO BG). This additional funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
