The Owensboro – Daviess County MPO is requesting to make the following TIP Administrative Modification #5, FY 2014 – 2019 TIP. This is a new project being added to the Owensboro – Daviess County FY 2014 – 2019 TIP.

**Project Description:** This would extend the existing Adkisson Greenbelt ending to KY Hwy 54.

**Scope of Work:** Construct 4, 700 ft. of asphalt trail, 10-12 ft. wide for walking, biking and skating.

**Phase:** Construction

**Type of Funding:** Recreational Trails Program

**Fiscal Year:** 2017

**Amount of Funding:**

**Other Information:** Recreational Trails Program is a project type identified in the Grouped Projects Table of the 2014-2019 MPO Transportation Improvement Program (TIP), therefore a formal TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP and MTP by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects Table involves a commitment of additional funding for the project by the project sponsor or funding agency. This additional funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
