The Evansville Metropolitan Planning Organization has processed the following administrative modification to the FY 2018-2021 Transportation Improvement Program (TIP).

TIP Administrative Modification


The City of Henderson requested the following modification:

Item# 02-713.00 Wathen Lane: Bridge replacement. Replace existing bridge with box culvert and guardrails. Add project for utilities (U) and construction (CN) in fiscal year 2018. This project is being administratively modified in the current TIP under the rollover provision. The project was programmed in the prior TIP, but did not let as scheduled in fiscal 2017. U costs of \$25,000 will be funded with \$20,000 in federal STP funds and a \$5,000 local match. CN costs of \$200,000 will be funded with \$160,000 in federal STP funds and a \$40,000 local match.

The modification will be presented as an informational item at the next Evansville MPO Policy Committee meeting.
