**ACTION:**

The Bowling Green-Warren County Metropolitan Planning Organization (MPO) hereby modifies the FY 2016 - 2020 Transportation Improvement Program (TIP) to reflect changes relating to the I-65 Spur corridor, connecting Bowling Green and Owensboro. Modifications to the existing project (03-2042.10) and the addition of a new signage project (03-2042.11) related to the I-65 Spur are listed below. The new project and revisions to project schedule and funding amounts are reflected in the tables on the following pages.

DESCRIPTION: Modification to move the unneeded \$200,00 from the right-of-way phase to include a utility phase for an agreement with the railroad.

DESCRIPTION: I-65 Spur Corridor Signing: Add signing to meet Interstate standards to existing Natcher Parkway from I-65 Interchange (Exit 2) in Warren County extending north to the US 60 interchange in Daviess County.

AMOUNT: \$2,150,000

Other Information: This TIP Modification modifies specific funding levels listed for NH projects in Table 1 of the TIP and modifies and adds the listed projects to Table 4. The added project (03-2042.11) includes I-65 Spur corridor signing for the entire 70-mile length of the corridor, including signing improvements in Warren, Butler, Ohio, and Daviess Counties. Highway Signing projects are a project type identified in the Grouped Projects Table of the TIP; therefore a TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP and Metropolitan Transportation Plan (MTP) by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects Table involves a commitment of additional funding for the project by the project sponsor (Kentucky Transportation Cabinet). The additional funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
