

The Owensboro - Daviess County MPO hereby modifies the Owensboro - Daviess County FY 2014 - 2019 TIP to reflect the following Administrative Modification:

Project ID: TR-02-0058

Project Type: Capital Maintenance - Rehabilitation of Transit Vehicles

Scope of Work: Minor rehabilitation and repair of existing revenue vehicles. Vehicles to be rehabilitated are FTA funded 30-passenger heavy-duty buses at the end of their minimum useful life. These vehicles are in need of structural and mechanical rebuilding in order to extend their useful life and decrease the need for replacement vehicle purchases.



Other Information: Rehabilitation of Transit Vehicles is a project type identified in the Grouped Projects Table of the 2014-2019 MPO Transportation Improvement Program (TIP), therefore a formal TIP Amendment is not necessary. TIP actions for these projects will not require additional public review.
