Scope of Activity:



Modification Description

Addition of projects per KYTC request for various maintenance and safety projects along US-60 and US-23 in Boyd and Greenup Counties.

Justification

To include above referenced projects per KYTC's request. Conformity determination is not required based on 40 CFR 93.126 Exempt Projects – Pavement resurfacing and/or rehabilitation (Ref #1) and Highway Safety Improvement Program Implementation (Ref #2-5). Neither project increase capacity nor will they potentially have adverse emissions impacts. These projects are included in the KYOVA 2018-2021 TIP Kentucky Grouped Project List, Item # BG-100 Pavement resurfacing/rehabilitation projects and BG-107 Bridge replacement/rehabilitation project with no additional lanes (Ref #1) and BG-129 Highway Safety Improvement Program Projects (Ref #2-5).
