

The Bowling Green-Warren County Metropolitan Planning Organization (MPO) hereby modifies the FY 2007-2012 Transportation Improvement Program (TIP) to revise the following projects and the summary of funding for Fiscal Year 2011. - Preventative Maintenance – Increase the existing Section 5307 budgeted cost for Fiscal Year 2011 from \$150,000 to \$226,500.
