

THINGS TO AVOID WHILE USING DEVICE

These can all cause the Ignition Interlock Device to detect alcohol which can lead to the initial failure of the test.

- Spicy Foods
- Sugary Foods
- Pizza
- Fruit & Fruit Drinks
- Vinegar
- Energy Drinks
- Vanilla Extract
- Mouthwash or Breath Spray
- Hand Sanitizers or Cleaners
- Perfume / Cologne

Use caution while using the breathalyzer.

RINSE YOUR MOUTH WITH WATER BEFORE TESTING!

When providing a sample, you must be seated in the driver's seat, and both you and the Ignition Interlock Device must be clearly visible to the camera.

ABOUT US

The purpose of an Ignition Interlock Device (IID) is to promote safe and responsible driving.

The goal of the Kentucky Ignition Interlock Program (KIIP) is to reduce alcohol-related crashes and traffic violations by allowing eligible individuals to continue driving—safely and legally—using an IID. The program encourages drivers to recognize and change risky driving behaviors, supporting both public safety and personal accountability.

COMPLIANCE

Once an IID is installed on your vehicle, you will be issued a restricted driver's license. You may qualify for a reduced suspension if you:

- Keep the IID installed for the Ignition Interlock timeframe shown in the chart below, and
- Stay violation free for the entire compliance review period.

IMPORTANT TO KNOW:

- The Compliance Review Period begins the day your restricted license is issued.
- Meeting compliance requirements does not guarantee a suspension reduction. By law, a reduced suspension must still be at least 90-120 days.

EXAMPLE: If you have a 3rd offense, you will carry the restricted license and keep the device installed for a minimum of 18 months before you have a compliance review. If you pass the review, your suspension will be reduced. If you fail, you will keep the device, and a new compliance date will be provided.

DUI Offense	DUI Suspension	Ignition Interlock Period	Compliance Review Period
1st Offense	6 months	4 months	90 days
2nd Offense	18 months	12 months	120 days
3rd Offense	36 months	18 months	120 days
4th Offense	60 months	30 months	120 days

VEHICLE OR VENDOR SWITCH OR REMOVAL

If you need to switch vehicles for your Ignition Interlock Device (IID) or change IID vendors, you must complete Form TC 94-204 and have it approved by KYTC.

IMPORTANT INFORMATION

You are only required to install a device on your primary vehicle; however, you may choose to install devices on additional vehicles.

The holder of an Ignition Interlock License is only authorized to drive a vehicle with an ignition interlock device installed.

Anyone can operate a motor vehicle with an ignition interlock device installed so long as he or she complies with the device requirements.

You will be considered in violation of the Ignition Interlock Program and subject to removal from the program for any program violations, which include:

- Failure to report for device monitoring
- Operating a vehicle without an interlock
- Failure to abide by the service agreement
- Tampering with the device
- Attempting to start/operate under the influence
- Failure to provide a sample as requested
- Accumulation of demerit system points
- Fail to enroll in, have no progress in, or withdraw from the DUI safety & treatment program
