This door hanger allowed the archaeology consultant to leave information for the property owners and tenants and led to a number of additional contacts.



The Kentucky Transportation Cabinet is undertaking additional archaeological studies for the proposed improvements to US 460 in Montgomery and Meniffee Counties.

We wish to advise that it is necessary for work crews to enter upon your property over the next few weeks to complete this study. Field personnel from Wilbur Smith Associates (WSA) will represent the Kentucky Transportation Cabinet. The work on your property is anticipated to take approximately 1 to 3 days. The study will consist of observation, physical measurement, photo-documentation, shovel testing and surface collection.

Any artifacts collected during these investigations will be cleaned and analyzed at WSA's office in Lexington, and then, with your permission, will be permanently curated at the University of Kentucky William S. Webb Museum.
