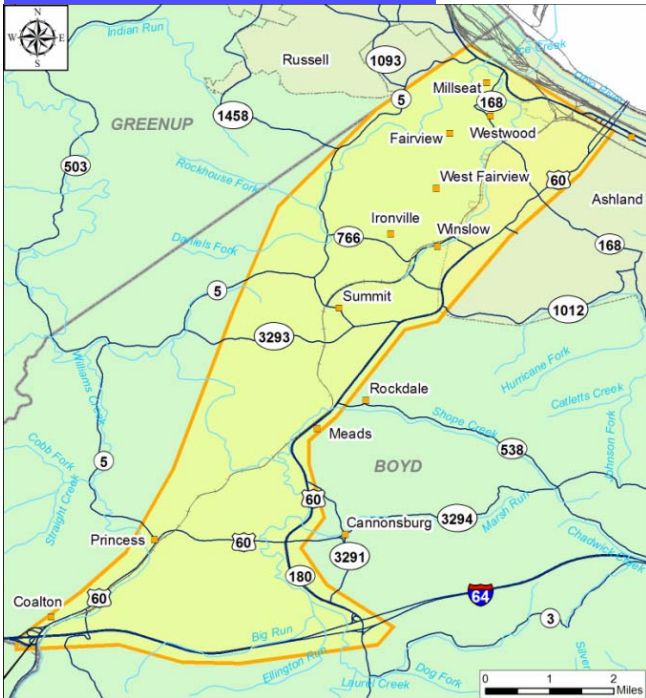

The Kentucky Transportation Cabinet has scheduled a Public Information meeting to discuss a planning study for improving access and mobility between I-64 and downtown Ashland. The purpose of the meeting is to inform the public of the planning study, discuss various environmental and technical issues concerning the project area, and solicit ideas and opinions that will help the Cabinet make decisions about the study. Anyone having an interest in the planning study is urged to attend this meeting.

This will be an informal meeting format so that you may arrive anytime during the scheduled meeting times and view the information. Exhibits and handouts will be available, and KYTC representatives will be present to answer questions and/or receive public input.

The exhibits will also be available for viewing from 8:00 am to 4:30 pm local time for fifteen (15) days after the meeting at the KYTC District 9 office, 822 Elizaville Road, Flemingsburg, Kentucky.

Both written and oral statements will be accepted at the meeting. A recorder will be made available to those who desire to make oral statements and a comment sheet will be distributed for written comments. Written statements will be accepted at the meeting and for a period of fifteen (15) days after the Public Information Meeting. All recorded and written statements will become part of the official record. Once compiled, the summary of this meeting and other supporting documentation will be made available for review and copying only after

an Open Records request has been received and approved. All Open Records requests must be submitted to the Transportation Cabinet, Office of Legal Services, Transportation Office Building, 200 Mero Street, Frankfort, Kentucky 40622.
