REQUEST FOR ACCESS TO THE KENTUCKY UTILITIES AND RAIL TRACKING SYSTEM UTILITY COMPANY OR CONSULTANT PERMISSION

The Kentucky Utilities and Rail Tracking System (KURTS) is primarily a system established for the internal coordination function of the Kentucky Transportation Cabinet (KYTC).

Select KYTC consultants may be provided access to this system as a representative of the KYTC. KYTC consultant representatives shall have rights and responsibilities similar to that of a KYTC staff member; to view select project data, review and approve utility relocation data, and retrieve utility data. These KYTC representatives may be provided access to data pertinent to specific road project activity.

The system provides for authorized utility company representatives to view select project data, submit utility relocation data, and retrieve utility data. These utility company representatives are selected by the utility company and KYTC may provide them access to data pertinent to their company activity.

Individuals requested to have access to KURTS via this permissions form shall have the authority to issue Electronic signature approvals on behalf of the responsible company in KURTS.

The individual(s) on behalf of a corporation, company, partnership, joint venture, or other similar entity named in this application, may sign and submit the application and said application must be accompanied by a power of attorney or resolution of authority from the applicant authorizing the signatory to act on its behalf; no exceptions.

CERTIFICATION:

Under penalties of perjury, I certify that the information given is true, accurate, and complete. The applicant(s) agree to comply with all reporting, payment, record keeping, agency/international agreements, federal, state and local statutes and regulations pertaining all inclusive to that of the Kentucky Transportation Cabinet and the Federal Highway Administration. The applicant(s) further agree that the Kentucky Transportation Cabinet is providing the applicant(s) access to project data and the opportunity to share data amongst a team of public and private sector representatives. Said data is not intended to be disseminated beyond those parties whom have direct access to the data provided. Failure to protect the security of all shared data shall result in forfeiture of access to KURTS and any other legal ramifications as provided by law in the Commonwealth of Kentucky. I further certify that the applicant(s) are familiar with the Kentucky Transportation Cabinet's utility relocation and accommodation policies as well as the Federal Highway Administration's relocation and accommodation policies and are sworn herein to adhere to those guides. The

applicant(s) understand that failure to comply with these provisions shall be grounds for revocation of any permission to access KURTS and/or authority in Kentucky Transportation Cabinet projects.
