- (4) Each offeror must submit priced offers responsive to the expressed requirements of the solicitation. ✓


Summary:

- All Four Quotes for the Mid-Size Car came in lower than the average Independent Cost Estimate price of \$21,170.
- All quotes were for the same purchase of a Mid-Size Car.
- Four responses were received as follow:

*Dutch's Chevy Ford #1 - \$16,890 (2019 Chevy Cruze)
Tim Short Chevy #2 - \$18,109 (2018 Chevy Malibu)
Dutch's Chevy Ford #3 - \$18,190 (2019 Ford Fusion)
Dutch's Chevy Ford #4- \$18,690 (2018 Chevy Malibu)*

All quotes are considered responsive and award is appropriately made to Dutch's Chevy Ford #1, (lowest quote) in the amount of \$16,890, which LVCAP determines to be a fair and reasonable price.
