Kentucky Transportation Cabinet on behalf of 10 rural transit agencies		Bus & Bus Facilities	The Kentucky Transportation Cabinet will receive funding to improve and expand transit service in 10 rural transit agencies that serve 45 counties by buying buses and equipment and upgrading facilities. The project will improve safety, service and reliability and lower maintenance costs for providers across the state.
KYTC	\$3,892,200	2023 Emergency Relief Program	Nearly \$3.9 million to the Kentucky Transportation Cabinet to support facility repairs after damaging storms, flooding, and landslides in the summer of 2022;

Reminders

- Lapsing/carryover Grant Balance Sheet At the end of October 2023, FTA will share your lapsing and carryover balances to update your current balances going into FFY2024.
- <u>ECHO</u> will close on Wednesday, **September 27, 2023 (2:00 pm EDT).** It will reopen for users at **2:00 p.m. EDT**, **Friday, October 6, 2023**.
- <u>TrAMS</u> closes **Monday, September 25**th.
 - This will affect all financial transactions such as funds reservation, grant obligation, award de-obligations, and financial purpose code/scope code transfers will be restricted. Users will still be able to use TrAMS for non-financial functions.
- <u>Anticipated Application Activity (AAA)</u> The new AAA spreadsheets will be shared in the first quarter of FFY2024 and due March 31, 2024. Any grants listed will be considered for award in FFY24. If there are some other circumstances which may come into play, any of those grants included on your submitted AAA spreadsheet will be considered for award beyond the May 31st deadline.
- <u>TrAMS Clean-up Please delete any old applications still in TrAMS that will not be used going into FY2024. Please reach out to your Pre-Award Manager or Community Planner if you have any questions or need assistance.</u>
- NTD Reporting As a reminder, 2022 ridership data will be used for NTD reporting. NTD urban and rural reporting presentations will be shared with you all for reference.

Reminders continued...

- <u>SAM Status -</u> If you are in the 90-day prior to your SAM status expiration date, please update begin
 updating it accordingly as it will impact our ability to award your grants.
- When building applications in TrAMS, please make sure to separate BIL funding (FY22, 23) from FAST Act funds (FY21 and prior) via different projects in the application. Funding from the two transportation bills cannot be combined in an application for award. TrAMS does not have the functionality to obligate and award the funds from the two separate transportation bills when combined into one project.
- MPO UPWPs Ensure your planning activities are being programmed into your MPO's UPWP with a reference to the FTA program and amount of funding (i.e. 5307, AoPP, etc).
- <u>TrAMS User Roles</u> A lot of agencies have been experiencing staff turnover so make sure that TrAMS User Roles are updated. Remember, this will prevent application processing delays (i.e. make sure you have a submitted to submit, and official to execute, etc.)
- <u>New project coordination</u> please remember to complete prerequisites as early as possible and to reduce project delays (i.e. NEPA for construction, TIP/STIP, flex transfers, etc.). If you need any technical assistance, please contact your assigned pre/post award managers.

- Investing in America signage On July 24th, FTA released Investing in America signage guidelines and templates to promote <u>construction projects</u> funded by ARP and BIL. If you have a construction project, please place the sign(s) at construction sites. R4 also shared an email with our recipients on 8/22.

Paducah, KY—IL	New Small UZA

• <u>Clarksville, TN-KY</u> Urban Area crossed 200k pop threshold = New Transportation Management Area (TMA) MPO

• Henderson, KY becomes a Section 5311 sub-recipient under KYTC

• Paducah, KY-IL Urban Area crossed 50,000+ population threshold = New MPO

2020 Census Updates continued...

Highlights of Census Change Scenarios:

- Small to Large Urban
 - Table 3A Operating Cap, 0.75% safety (5307)
 - FTA/FHWA planning documents preparation and oversight
 - New designated recipient(s) will be needed
- Rural areas to Small Urban
 - Eligible to use 5307 funds
 - Not eligible to use 5311 funds in the small, urbanized area
 - Coordination with State DOT for Urban Area funding allocation
- Urban Areas to Rural Areas
 - Coordination with the State DOT to use 5311 funds
