

## Workaround- Dealer Assignments with Transfer

Below are the step for a work around if a user has a Dealer Assignment with a transfer. First, the PVA will need to make the future year segment on the previous title 'non-taxable- current. Once that action has been completed, then the clerk can continue the transfer.

Steps to verify you can transfer the Dealer Assignment:
