1. 20685: Product Backlog Item-Temporary Tag Reversals

Description: This user story gives clerks the ability to refund customers for Temporary Tags. This is applicable on a Customer Account and an Auto Dealer Account. A new reverse button will display in the temporary tag section on the Customer/ Dealer Account Pages to give the ability to process a reversal when needed.

2. 31780: Product Backlog Item- NTA - Vehicle Must have minimum of \$6.00 even if trade-in

Description: This user story provides the correct calculations on Usage Tax based on the minimum value of \$6.00. This rule is for all vehicles except for the following vehicle types: "MI","TC", "KT". This user story will help the correct Usage Tax be submitted to DOR.

3. 33066: Product Backlog Item-TV - Edit Owners - Extend to Surrendered Titles

Description: This user story gives MVL Supervisors the functionality to Edit Owners for titles in Surrendered state. This will give them be ability to correct ownership on previously owned vehicles that may have issues or have been incorrectly associated with a wrong customer.

4. 40961: Product Backlog Item- KAVIS Reports - Heavy Weighted Truck Renewal Report

Description: This user story gives the ability for clerks to view a list of all registration renewals requiring the 2290 form performed in the county clerk's listed county. This report will be listed under the KAVIS Report section and is titled: Heavy Weighted Trucks Renewal Report. The clerk will have to choose the desired dates and select view on the Reports Page to pull up the report.

5. 40721: Product Backlog Item- NTA - Utility trailer fees are not dropping into the Shopping Cart

Description: This user story adds the functionality to drop Utility Trailer fees into the KAVIS Shopping Cart. This user story ensures that the dealer- to- dealer fee (\$6.00) is dropping to the shopping cart and mapped appropriately. Also, this user story makes it possible for a Dealer Assignment of the Utility trailer can be checked out.

6. 41432: Product Backlog Item- POS Mapping - Modify Additional Usage Tax split into 70/30 on POS reports

Description: This product backlog item gave Pulaski County a report of their miscellaneous item 'Additional Usage Tax Collection' split into 70/30 on their POS reports to understand how much they should pay to the state.

7. 40872: Bug- Forced Reg timeout creating two titles at checkout

Description: This bug works on an issue the clerks reported for timing out on Forced Registration Actions. This issue would also produce multiple of the same transaction on the receipt and in the Sales Activity. Both of these issues are now corrected and clerks should not experience timing out when trying to complete a Forced Registration Action.

8. 41150: Bug- Lien Processing Report not pulling all Liens for 3/25/25 - Grant Co

Description: This bug corrects the issue where the "Lien Processing Report" was not pulling all liens for Grant County during the time inputted. This is now fixed and should not happen to any other counties.

9. 41268: Bug- Plate Conversion rows in Registration table should not have registration fees

Description: This bug corrects the issue where rows in the registration table that are marked "88" should not have registration fees but do. This is now corrected and is showing correctly.

10. 41382: Bug- Untethered Plates performance improvement

Description: This is a bug that improves the performance of the untethered plate table search functionality. Currently, when searching for a plate on the untethered plate table, it adds about 6 seconds to the plate search. This has been reduced and should no longer take as long to perform this search.

11. 40417: Bug- Records on TSaleItem table are not being marked as reversed when UnitPrice is negative

Description: This bug researched the issue on the Remittance Report when the calculations of the Item Total, is summed up from the Unit Price\* Quantity and it shows a short discrepancy. This bug researched and fixed this problem.

12. 41482: Bug- Edit Owner on Surrendered Title

Description: This bug is in conjunction with the story above, 33066. When trying to remove the 2<sup>nd</sup> owner, which was part of the 1<sup>st</sup> owners name that is on the surrendered title KAVIS cancelled the registration. This was found during testing and was worked and corrected.

13. 40399: Product Backlog- Prevent Application of Personalized Plates When Plate # Already in Use

Description: This user story ensures that a Personalized Plate Application will not be created for plates on the untethered plate table or that are currently in use. Because of the way KAVIS was structured without this user story, Personalized Plate Applications were being created for plates that were currently in use. This user story updates logic in KAVIS and the lookup functions in the database to lessen the confusion when a new Application needs to be created.
