Priority Stories:

1. New Plate Types to KAVIS

Description: KAVIS is working with ITI to add several new plate types to the KAVIS database.

- Blackout; Pers Blackout

- Suicide Prevention; Pers Suicide Prevention
- Promote Peace; Pers Promote Peace

- Beautify the Bluegrass; Pers Beautify the Bluegrass

2. MVL Surrender titles in Applicable Statuses

Description: This user story give MVL the ability to Surrender "Active" and/or "Application Cancelled". This provides a solution to the issues where MVL would surrender a title for an off-road vehicle, then the clerk would start a title application for the SLSPV with the same VIN, MVL would try to surrender the Off-road title a second time and receives a JAVA script error.

3. Update certificates for CHFS.

Description: This user stories updates certificates for CHFS.

4. Out of State Transfers to Jefferson County Report

Description: This is a report requested by Jefferson County to categorize and provide data on all the out-of-state transfers processed in Jefferson County within the last year.

5. Temporary Registration Functionality and Fee

Description: This user story allows Dealers to user Customer's existing license plates on a trade- in vehicle for a temporary registration to be in compliance with KRS 186A.100.

Priority Bugs:

6. Selecting and deselecting plate replacement on manage page throws SC error

Description: This bug fixes the issue where a user would click and unclick the plate replacement checkbox and the renewal will fail at checkout.



7. Repo usage code error when checking out

Description: This bug corrects the issue where a County Clerk was trying to process a repossession lienholder transfer, and the usage code "NA" was giving an erorr in the shopping cart.



8. Multiple placards cannot be reversed together

Description: The bug that was causing placards that were checked out together, but had to be reversed separately is now fixed. A user can now reverse the placards that were checked out on the same receipt together.

9. Temp tags limit not reached but error for max used displays

Description: This bug fixes the problem where users were adding multiple temporary tag ranges into the cart and getting stopped with the following error message at checkout:

"The number temp tags issued this year and temporary tags being issued in the added Temp. Tag range(s) exceed the temporary tag limit of this dealer"



10. Body style cannot be edited and saved when title is in application status

Description: This bug fixes the issue where the Body Style could not be updated, on the Vehicle Summary Page, when the title was in Application Status.

11. Ky transfer Boat DA will not add reg and fees

Description: This bug corrects the issue where a KY Boat transfer with an Active-Dealer assignment will let you add a registration but does not add any fees to the cart or add expiration date to the registration.

12. Extra Review selection and comment box are missing from NTA Additional Info

Description: This bug addresses the error where the 'Extra Review' checkbox and Comment box was not showing up on some title actions. These actions should appear on every title application.

13. Access to sheriff inspection button

Description: This bug corrects the issue where users with add/edit customer role were not able to access the Sheriff's inspection button. That is now fixed and those roles should be able to access the Sheriff's inspection button.

14. Delinquent current year ad val not being included with renewal during update NTA

Description: This bug corrects the issue where Delinquencies are stopping KYELT Dealer Assignment transactions. The delinquencies should not be there and will be corrected with this release.
