SPECIAL NOTES APPLICABLE TO PROJECT

After the closure of KY 610 and the removal of the existing bridge, the road shall be reopened to traffic by November 30, 2018. Contrary to Section 108.09 of the Current Specifications, the Department will apply a Daily Charge of \$4,000/day if the road is not opened by the date listed.

The contractor is advised that the AT&T utility relocation is scheduled to be completed by September 1, 2018. The contractor shall coordinate with any utility companies regarding any relocation activities that have not been completed prior to the beginning of work by the contractor.
