DEFERRED PAYMENT

The successful bidder on this project has the distinct understanding that payment for any work may be delayed until July 15, 2024. Work Order/Notice to Proceed will be issued in accordance the Standard Specifications for Road and Bridge Construction, current edition.

SURFACING AREAS

The Department estimates the mainline surfacing width to be varied 16 to 19 feet.
The Department estimates the total mainline area to be surfaced to be 50,025 square yards.
The Department estimates the shoulder width to be N/A foot on each side.
The Department estimates the total shoulder area to be surfaced to be N/A square yards

ASPHALT MIXTURE

Unless otherwise noted, the Department estimates the rate of application for all asphalt mixtures to be 110 lbs/sy per inch of depth.

INCIDENTAL SURFACING

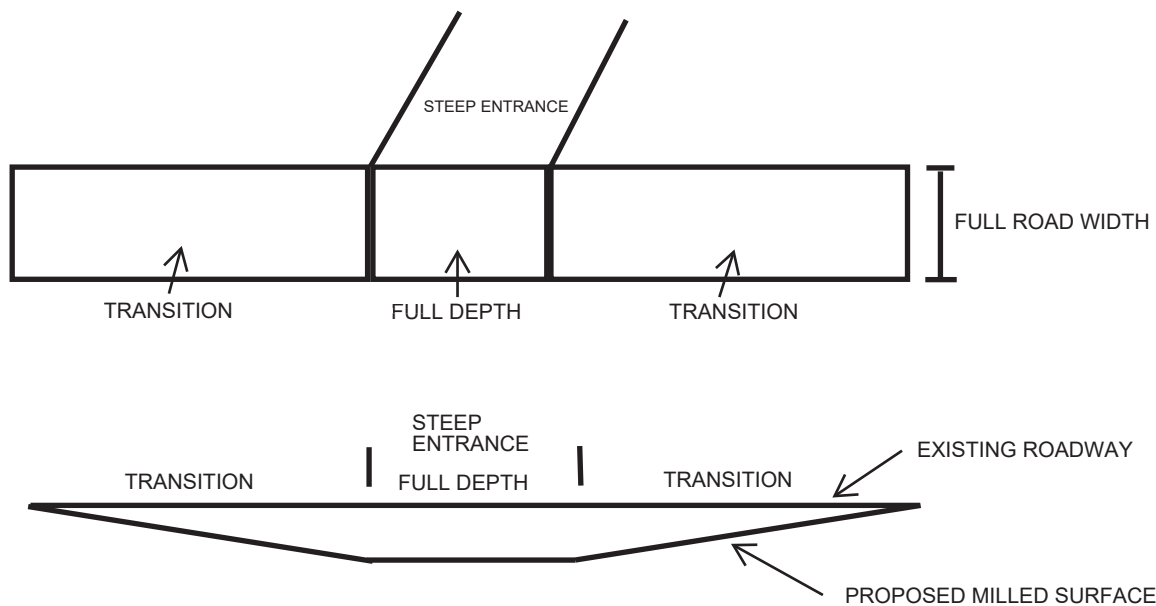
The Department has included in the quantities of asphalt mixtures established in the proposal estimated quantities required for resurfacing or surfacing mailbox turnouts, farm field entrances, residential and commercial entrances, curve widening, ramp gores and tapers, and road and street approaches, as applicable. Pave these areas to the limits as shown on Standard Drawing RPM-110-06 or as directed by the Engineer. In the event signal detectors are present in the intersecting streets or roads, pave the crossroads to the right of way limit or back of the signal detector, whichever is the farthest back of the mainline. Surface or resurface these areas as directed by the Engineer. The Department will not measure placing and compacting for separate payment but shall be incidental to the Contract unit price for the asphalt mixtures.

OPTION B

Be advised that the Department will control and accept compaction of asphalt mixtures furnished on this project under OPTION B in accordance with Sections 402 and 403.

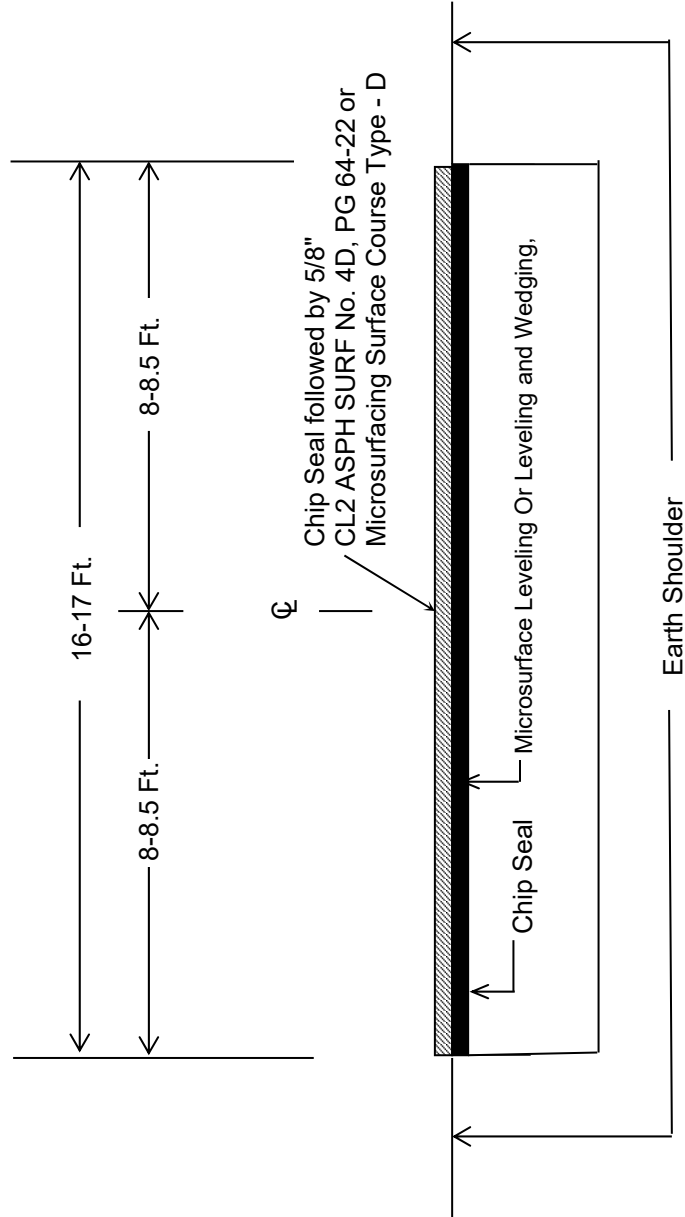
SPECIAL NOTE FOR MILLING AT STEEP ENTRANCES

At the locations listed in the milling summary or as directed by the engineer, mill the roadway full width, and to the depth of the proposed pavement thickness where steep entrances are located, and transition to existing pavement on each end of the entrance. See an example in the detail below.



NOTE: THE TRANSITION LENGTH IS BASED ON 100 FT/INCH OF THICKNESS.
NOTE: NO MILLING WILL BE REQUIRED IN THE ENTRANCES.
