QUESTION: Please advise if structural design should be a prequalification requirement for both the KY 207 and KY 773 projects. Both list that the consultant will perform structure design (on page 2) but structural design is not a prequalification requirement.

RESPONSE: KYTC inadvertently left off Structure Design Prequalification and has made this correction for both 2010-06 Carter/KY 773 9-8312.00 & 9-8312.00 and 2010-06 Greenup/KY 207 9-8509.00. KYTC will have the option of modifying both of these for Phase II final roadway design and structure design if needed. Structure Design Prequalification will be required for both 2010-06 Carter/KY 773 9-8312.00 & 9-8312.00 and 2010-06 Greenup/KY 207 9-8509.00.

2010-06 / Greenup / KY 207 / 9-8509.00

QUESTION: Transportation Corridor and System Planning is listed as a prequalification requirement. Work associated with this prequalification requirement typically is associated with more urbanized areas with larger systems linkage and network interactions than seems to be the case with this project. Please advise if the Cabinet would consider eliminating Transportation Corridor and Systems Planning prequalification as a requirement for this project.

RESPONSE: KYTC has considered your request and has decided to keep the prequalification requirements as originally written into the advertisement. Transportation Corridor and System Planning prequalification will be required to respond to the 2010-06 Greenup KY 207 9-8509.00 project.

### **Additional Information added to Special Instructions:**

The Selection committee will randomly draw from the pool and list in consecutive order to determine the initial order for which a project will be offered. Projects will be offered to firms on a rotating basis. A firm will not be offered an additional project until the remaining firm on the list has been offered a project. If a firm declines to accept a project, that firm will not be eligible to accept another project until the remaining firm on the list has been offered a project. If a firm declines a project; does not respond to an invitation to perform services for a project within fourteen days; or the Department and Consultant cannot agree on a reasonable scope of work and fee for services, documentation shall be placed in the project files and the next firm on the rotating list shall be offered the project.

## 2010-06 Carter Co KY 733 9-8312

**QUESTION:** Prequalification in "Transportation Corridor and Systems Planning" along with related services is required according to the announcement. This seems like a high level of involvement for this type of road. Wouldn't Highway Planning Services be a more appropriate requirement for this project?

**RESPONSE:** Since this project will require minor planning for the route, but no overall corridor or regional planning, KYTC agrees that "Highway Planning Services" is the appropriate prequalification requirement. Prequalification in "Transportation Corridor and Systems Planning" will not be required, however, prequalification in "Highway Planning Services" will be required for the Carter Co / KY 733 / 9-8312 project.

**CLARIFICATION:** It is also the intention of KYTC to remove prequalification requirement for Traffic Forecasting, Traffic data Collection and Traffic Demand and Simulation Modeling.

**QUESTION 1:** Because of the size of the project and the inclusion of planning and environmental services, can two additional pages be allowed in the project approach?

**RESPONSE 1:** KYTC will allow 2 additional pages in the Page 7 Project Approach for a total of 5 pages (A-E) for Greenup County – KY 207 – 9-8509.00 response to announcement.

**QUESTION 2:** It is not clear whether or not DBE goals are a part of the

project. Please clarify.

**RESPONSE 2:** DBE participation is not a factor for consultant selection on Greenup County – KY 207 – 9-8509.00.
