

Modification Descriptions

To modify KYOVA's 2018-2021 TIP and KYOVA's 2040 MTP to reflect new cost estimates.

Justification

Modify construction STP funding per KYTC request. Project is considered exempt from the requirements to determine conformity based on 40 CFR 93.126 – Safety: Widening narrow pavements or reconstructing bridges (no additional travel lanes). This project does not add capacity. KYOVA's 2018-2021 and 2040 MTP, and Participation Plan includes Bridge Replacement/Rehabilitation projects with no additional travel lanes as "Groupable" with BG-107 – Bridge replacement/rehabilitation projects with no additional lanes.
