**SUBJECT:** Notification of <u>Administrative Modification #22</u> to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #41 to the 2045 Metropolitan Transportation Plan (MTP)

On August 26, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #22 to the FY 2021 – 2024 TIP and Modification #41 to the 2045 MTP.

#### Administrative Modification #22:

This action updates the previously published documents and tables. This modification is considered a Grouped Project\* (Intersection Improvements for Safety or Efficiency) which does not impact financial constraint of the TIP. The modification adds the following project:

#### West Main & Buchanan Safety Improvements:

• \$1,120,000 (80% STBG-SLX) + \$280,000 (20% State match) = \$1,400,000 Total
