On September 14, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #23 to the FY 2021 – 2024 TIP and Modification #41 to the 2045 MTP.

Administrative Modification #23:

This action updates the previously published documents and tables. The modification adds the following Grouped Projects* (Ferry Boat Capital and Operating Assistance) which does not impact the financial constraint of the TIP:

- Valley View Ferry Authority:
 - Replace Ferry Boat Cable System
 - o \$47,068 (80% Fed Ferry Boat Program funds) + \$11,768 (20% Local Match**)= **\$58,834 total**
