Improvement Program (TIP) and Administrative Modification #43 to the 2045

Metropolitan Transportation Plan (MTP)

On November 28, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #25 to the FY 2021 – 2024 TIP and Modification #43 to the 2045 MTP.

Administrative Modification #24:

This action updates the previously published documents and tables. This modification updates and adds those projects from the 2022 Enacted KYTC Highway Plan that do not require a TIP amendment. Those projects requiring an amendment will be added at a future date.

This modification **updates** the following projects as described:

- Citation Blvd Section III-B (Winburn Dr to Russell Cave Rd) (ITEM# 7-265.00 / MPO# 04)
 - o Add \$3.5M in STBG funds (\$2.8M Federal + \$0.7M State) for the Construction phase in 2024
- Brannon Rd Improvements (US 68 to US 27) (ITEM# 7-414.00 / MPO# 51)
 - Move Utilities phase from FY 2023 to FY 2024
- **Drake Lane Bridge** (ITEM# 7-1144.00 / MPO# 49)
 - o Add \$210K in STBG funds (\$168K Federal + \$42K State) for the Design Phase in 2023
- East Nicholasville Bypass 1A (ITEM# 7-87.20 / MPO# 9)
 - o Increase Construction phase from \$16.9M to \$19.6M in SPP funds (100% State)
- I-64 Pavement MP 82.19 (west of Cleveland Rd) to MP 89.48 (Clark Co Line) (ITEM# 7-20011.00 / MPO# 16)
 - Combine FY 2022 and FY 2023 Construction Phases in FY 2023 without changing fund or cost

 - o Move C from FY 2021 to FY 2025. Which removes project from current TIP
