RESOLUTION APPROVING AMENDMENT #12 TO THE KYOVA 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

- WHEREAS, KYOVA Interstate Planning Commission has been designated as the Metropolitan Planning Organization (MPO) by the Governors of West Virginia, Kentucky and Ohio for the Huntington, WV-KY-OH Urbanized Area acting through the West Virginia Department of Transportation/Division of Highways (WVDOH), the Kentucky Transportation Cabinet (KYTC), the Ohio Department of Transportation (ODOT) and locally elected officials in the KYOVA region; and
- WHEREAS, KYOVA has adopted a 2021-2024 Transportation Improvement Program (TIP); and
- WHEREAS, the Kentucky Transportation Cabinet requested an amendment to the current 2021-2024 TIP to update and/or add the attached roadway projects; and
- WHEREAS, the project information was available for a 15-day (November 17, 2022 through December 2, 2022) public review as outlined in the KYOVA Participation Plan and received no comments; and
- WHEREAS, no conformity report is required for Huntington, WV-KY-OH Urbanized Area due to the court vacating the revocation of the 1997 8-hour ozone standard. This area is in attainment for the 2008 and 2015 8-hour ozone standard; and
- WHEREAS, the insignificance finding of the 1997 PM2.5 annual NAAQs means no regional modeling is required as the Huntington-Ashland area is in attainment for the 24-hour 2006 PM2.5 standard; and
- **WHEREAS,** the Interagency Consultation (IAC) has determined the proposed project amendments to the 2021-2024 TIP are not subject to conformity and therefore exempt;
- **NOW, THEREFORE, BE IT RESOLVED** that the Policy Committee of the KYOVA Interstate Planning Commission, at a regularly scheduled meeting on December 9, 2022, adopts the attached project list as Amendment #12 to the KYOVA 2021-2024 TIP.

The Public is hereby made aware that the KYOVA Fiscal Years (FY) 2021-2024 Transporta-tion Improvement Pro-gram (TIP) for the KYO-VA Interstate Planning Commission Planning Area is being amended Area is being amended in accordance to the Infrastructure Investment and Jobs Act (IJA) effective on November 15, 2021, in coopera-tion with the West Virgin-ia Department of Trans-portation - Division of Highways (WVDOH), Ken-tucky Transportation Cabinet (KYTC), Ohio Department of Transpor-tation (ODOT), Federal Highway Administration (FHWA), Federal Transit Administration (FTA), Tri-State Transit Authori-ty (TTA), Ashland Bus System (ABS), and Law-rence County Port Au-thority (LCPA). ment and Jobs Act (IIJA)

The FY 2021-2024 TIP is for the KYOVA Inter-state Planning Commis-sion's Planning Area which includes: Cabell which includes: Cabell and Wayne counties in West Virginia; Boyd and Greenup counties in Kentucky; and the urbanized area of Law-rence County in Ohio.
