SUBJECT: Notification of **Administrative Modification #43** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #61 to the 2045 Metropolitan Transportation Plan (MTP)

On January 29, 2024, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #43 to the FY 2021 – 2024 TIP and Modification #61 to the 2045 MTP.

Administrative Modification #43:

This action updates the previously published documents and tables. This modification moves STBG-TA funding between phases for one grouped¹ project, which does not impact the financial constraint of the TIP.

Citation Trail – Section 2:

This modification moves \$100,000 (\$80,000 in Federal STBG-TA (80%) + \$20,000 Local Match (20%)) from the Construction phase to the Design phase to cover cost increases.
